Mr. Nelson:

- 1. Attended first and second Education's Digital Future seminar at Stanford and talked with two MVWSD teachers and Assembly member Gordan's educational staff member. There are very few districts in County that have logical Technology personnel training or job descriptions.
- 2. Attended the architect meeting at Theuerkauf for the Theuerkauf/Stevenson configuration. I noticed that there is a large imbalance, with Theuerkauf

community representation on the short end.

- 3. Attended the Parcel Tax Oversight gathering (which didn't have a quorum) and distributed a cover sheet on Borikas case Parcel Tax issues.
- 4. Heard CSBA's Roadshow update at the Country Office and made a personal connection to the Educational Legal Alliance lawyer. He has worked closely with Berkeley USD member (& lawyer) Josh Daniels on the Borikas case about the Parcel Tax uniformity requirement.
