Introductions

A structured discussion to intentionally create new healthy and productive team norms. Discussion includes not only how the team wants to be together in good times but when things get difficult. Creates an environment that supports safe and honest communication; enabling board members to express their viewpoints in a productive way.

To ensure the Board is meeting its objectives as well as holding to the Designed Team Agreement.

Connection to the District's Strategic Plan

To practice applying the DTA and other learnings in real-time by discussing, at a high level, how the Board wants to proceed monitoring and completing next year's goals in the Strategic Plan.
